# **President's Message - Bruce Fitzpatrick**

Dear Families and Friends,

I have the opportunity to read newsletters and annual reports from many human service agencies. It strikes me that most of what I read is about the business of operating an agency and fund raising, and little about the persons served. For the past several years I know that the Messenger has tried to maintain a balance between keeping our readers aware of the "forces" impacting the business and operations of the Manor, and what the men at the Manor are doing on a daily basis. If you feel that we lean too far one way or another, please do not hesitate to contact Amy Carmack or myself.

I would like to congratulate our Special Olympics participants on a terrific year to date. We are the reigning Senior Division Basketball State Champions. In the summer games held in Bloomington our men participated in Bocce Ball and received nine medals, and in Track and Field events the men received seven medals. The men are now working on their baseball skills.

The men have also participated in many special activities including a Yacht trip on Lake Michigan, a trip to the Washington Park Zoo, an evening at the horse races, and many baseball games for the Sox and Cubs. The Chorus and Signers were on television during a recent telethon. The rainy weather has provided steady grass growth for the mowing crew and the sheltered workshop has maintained a continuous supply of work. We are happy to report that, on average, we have exceeded our goal for the number of men working and volunteering in the community.

The lifecycle continues at the Manor. We mourn the loss of Eddie Koci and Tom Buffenmyer. Eddie was 64 years of age and had lived at the Manor nearly 39 years. Tom was 59 years old and also came to the Manor in 1971. Eddie and Tom will each be memorialized with plaques in the main Chapel. We also want to welcome our newest resident to Lombard House, William "Billy" Bell. See Pages 4 and 5 for photos and information about our most recent clients.

We are very excited to have been awarded a three-year accreditation from CARF – the Commission on Accreditation of Rehabilitation Facilities. This is the fifth consecutive three-year accreditation and indicates a "dedication and commitment to improving the quality of the lives of the persons served."

The financial crisis in Illinois and the State budget continues to make it difficult to plan and budget with a high degree of confidence. The current State budget does cut funding for Human Services with additional cuts of 2.5% or more still in the discussion phase. I can say with certainty that we will not receive a cost of living increase from the State for the fifth consecutive year.

I can also say with confidence that we are very fortunate to have the support of our families and many benefactors. Once again, the Brunch Auction and the Balmoral Golf Outings were very successful; thank you to the chairpersons of these events. Thanks to the generosity of our benefactors: 1) we are in the process of upgrading our phone system to better identify where a 911 call is made from, 2) we have added generators to several group homes, and 3) we have been able to update the bathrooms at Lombard and Herbstritt homes. We all are very appreciative of your continued support.

I do realize that a Mission without money will not have many accomplishments. The Mission of Good Shepherd is to serve the needs of the men who live here. Our Board of Trustees is absolute in their dedication to the Mission and concern for the safety and quality of care for the men at the Manor. The support from our benefactors allows us to meet our Mission. We are truly blessed to have this union of Mission, dedication, and support all focused on serving the needs of the men. On behalf of the men, the Brothers, and the staff of Good Shepherd, I would like to say thank you to our Board and benefactors.

Mike Hill came to GSM as a resident on March 7, 1976. He passed away 33 years later on June 25, 2009. He continues to be missed by all. This is a story about his family. His folks, Dean and Jean, were two of the earliest members of the Shepherds Endowment Society. Recently Mike's four siblings also joined. This is their story. We thank Mike's brother, Doug and Doug's wife, Cathy for writing this story and providing the family photo.

Back when Mike first started living at Good Shepherd Manor about 30 years ago, the family set aside about \$20,000 in "emergency money" just in case Mike needed something that the State or GSM could not provide in the future. Whatever was left of the emergency money was to be divided amongst Mike's siblings upon his death. For the entire 30 years the money was never spent, and was invested and reinvested in various funds. It went up and down, but mostly up. By the time Mike died, it had grown to more than \$100,000. Since Mike would no longer need the money, it became time to distribute it. But what would Mike want done with it? Mike had many loves in life: school (especially Galesburg High School), Special Olympics, travelling, eating out, and visiting with anyone who would listen. But nothing meant more to Mike than

his relatives and his friends at GSM...and a good cup of coffee! We decided that Mike would want his friends to continue to be well-cared for just like he was. Good Shepherd Manor was very good to Mike over the years, and his death won't end the need to keep on caring for his old buddies and others to come along in the future. His life is over but the work and love goes on. So we decided to make the gift of \$100,000 to the Manor. The remainder will be donated to a Knox College fund used to help disadvantaged Galesburg area students who would otherwise not be able to attend college. Knox was the only college Mike really knew anything about as it is located in his hometown, and was attended by Mike's mother, father, brother and uncle.

# Happy Summer Season to you all! The Infirmary staff has welcomed Michelle Purnell as full-time

Michelle was referred to Good Shepherd Manor by Ashley Munson, overnight care worker.

As the summer sun beams upon us this season, please remember, nearly all of our residents take medications that make them more susceptible to sunburn. Blood pressure medications, diuretics, antihistamines and certain psychotropic medications can all interact with the sun. Please make sure that if you take your family member outside, even on a partially cloudy day, that you apply sunscreen to all exposed skin... paying special attention to ears, back of neck,

noses, and in many cases, thinning hair areas on the top of the head unless the person will be wearing a cap. Additionally, please familiarize yourselves with the signs and symptoms of heat stroke and heat exhaustion listed below.

# People at Risk during Hot Weather

\* People with circulatory or respiratory problems

\* The Very Old or the Very Young

\* People on certain types of medications, including:

**Diuretics** Anti-hypertensive medications Sedatives **Hypnotics** Tricylic Anti-depressants

#### **PREVENTION OF HEAT RELATED OCCURENCES:**

Give extra fluids (1/2 cup per hour when over 85 degrees) unless on fluid restriction Keep out of the heat Keep cool

State of weakness produced by the loss of body fluids & salts from heat exposure

Symptoms cool & clammy skin with perfuse perspiration slight elevation of temp pulse weak, thready, & rapid respirations shallow & quiet

# **Heat Stroke**

Results of direct exposure to high temperatures or sun

Symptoms dizziness weakness bright red skin rapid strong pulse unconsciousness usually follows

- The Board of Directors is very active in the life of the organization, providing excellent guidance and leadership. The Board does an excellent job of overseeing the organization's programs and services, financial situations, and long-range planning.
- The organization benefits from employing a president who has compassion for the persons served and a vision of seeing each individual, regardless of his disability, achieve his full potential.
- GSM is praised for its fund-development efforts. Grant writing and year-round fund-development activities help offset some of its financial losses.
- The tenure and commitment of the direct line staff and the management team at GSM are commendable. The organization benefits from personnel who are stable, knowledgeable, and committed to the mission of the organization.
- Funders express a high level of satisfaction with program services. One funder said, "They do things for their residents that other agencies simply do not do." Another funder said, "They are truly caring people."
- The organization is recognized for its recent addition of a full-service infirmary. Residents can access primary care services, receive on-site x-ray services, receive preparation for special procedures, and even receive hospice services in this setting when needed.
