The holiday season is upon us and fittingly we start with a day of thanksgiving. We at the Manor have been abundantly blessed and are thankful for our blessings.

The men are very excited about moving into the new group home. Construction is progressing well and we hope to move into the home in January. We are taking advantage of this construction to provide city water to all of our

buildings. This past spring automatic generators and fire sprinkler systems were added to all of our homes. This coming year Brother Alphonsus Drive will be repaved. We are thankful for the opportunity to improve the comfort of the men's homes and their living environment.

I am also happy to report that the programs which serve the men are very successful:

- 100% of the men participated in community activities each quarter
- On average, each man participated in a community outing each week
- 50 men participated in community work each quarter
- Continuous work was provided in the sheltered workshop
- 84% of the men learned a new home-based skill
- The Raider Volleyball team is the reigning Division IV State Champions

We are thankful for the opportunity to serve the more than 260 men who have come through Good Shepherd Manor over the past 40 years.

The most recent Fall Festival was a tremendous success, the weather was perfect and the entertainment could not have been better. We also realized a very successful Brunch Auction and Golf Invitational this past year. The family response to the sprinkler/generator drive provided enough funds to complete the entire project. This year the Shepherds Endowment Society will provide funds to support the programs which serve the men. A Glimpse of Good Shepherd Manor in 2011...

The typical client served by Good Shepherd on 6/30/11 is 56 years old and has lived at the Manor nearly 22 years. He is developmentally disabled and has at least one additional medical diagnosis, likely affecting the cardiovascular system. 54% of the men function in the moderate range of impairment and about 1/3rd have mobility impairments. 73% of the men participate in either or both the developmental and vocational programs while 27% are in the seniors program. About one third of the men participate in extra-curricular activities (chorus, signer, or Special Olympics). Most men have goals related to home management, medication administration, economics, and community integration.



Greetings from the Infirmary!

With the holidays approaching, once again our thoughts turn to cold and flu season. It is important for the men at Good Shepherd Manor to have the protection of the Influenza vaccine each year as many of them are more susceptible to this illness because of concurrent medical conditions. (See client medical conditions below)

The influenza vaccine that is given to the men of Good Shepherd Manor is not a "live virus" such as is found in the nasal spray type vaccines, it is a "deadened" virus. That is, you cannot "get the flu" from the injectable vaccine used for the men. Unless someone has a reaction to the vaccine itself, if you become "ill" after getting

the vaccine, most likely it is because you have been exposed to the virus before your body has had enough time to build up the protective antibodies.

Shepherds Endowment Society Member Spotlight

Members of the Shepherds Endowment Society represent a broad cross-section of people from around the country with a wide variety of "connections" to the Manor. In an effort to "catch up" with the growing membership, in each issue we will focus on one earlier member and one of our newest members.



Jack and Marge Hayes Joined SES: October 27, 2006 Why did you join the SES?

<u>Jack:</u> As a member of the Good Shepherd Manor Foundation Board, I participated in the initial planning meetings for what would become the Shepherds Endowment Society, mainly for the purpose of insuring that the accounting and investment requirements would not be burdensome or costly. At that early stage, I did not give much thought to becoming a member. Coincidentally, in 2004 and 2005, as the Society was being planned and established, the State of Illinois was beginning to experience what

appeared to be long-term financial problems. Gradually, I began to realize that if the State were to become unable to pay for the care of people with disabilities, or if regulations were changed in a manner to make the Manor's facilities ineligible for State funds, the existence of Good Shepherd Manor and the very lives of the residents, including my brother, Tom, could be in danger. At that point, I decided to do whatever I could to insure that the Manor would have a permanent source of long-term funding, independent of the whims of politicians and other outside influences.

Marge: While working for 38 years with children having developmental and physical disabilities, I learned that the disabled can be very fragile, but also that they can lead happy lives and bring joy to others, if only they have loving care and training. In the 1980s, after Jack's and Tom's mother became unable to independently volunteer at Good Shepherd Manor, I began working on the Fashion Show and Fall Festival, and I became ever more appreciative of the dedication of the leadership, staff and volunteers who gave so much of themselves to the care of Tom and all of the residents. When the Shepherds Endowment Society began, it was an easy decision to participate.

Connection to the Manor: Tom Hayes, Jack's brother has been a resident since June 1971.

John and Connie Munnelly are the proud parents of William Munnelly. William has been a regular visitor of the Manor for more than 18 years. Good Shepherd Manor has become a place of "R & R" for William as his parents travel, speak, and visit throughout the U.S. and internationally. John, a retired Colonel with the U.S. Army served 33 years of active duty and was in three wars. He and his wife Connie have planned for William's eventual move to Good Shepherd Manor through these regular visits.
